### General Information

ClawEL Debris Delete is specifically designed to break down crop residue in the field, improving planter performance and releasing valuable nutrients to feed the crop..

### Rate Recommendations

Row Crops: Apply 12.8 fl oz per acre to crop residue as a broadcast application after harvest. ClawEL Debris Delete may be applied with typical herbicides and fertilizers used in spring and fall burndown applications.

Cover Crops: Apply 12.8 fl oz per acre as a broadcast application to terminate cover crops or in combination with the termination spray to accelerate residue breakdown. ClawEL Debris Delete may be applied with herbicide at the time of termination.

Fruit and Vegetable crops: Apply 12.8 to 32 fl oz per acre postharvest using the irrigation system when possible as a broadcast spray. ClawEL Debris Delete may be applied with typical herbicides and fertilizers.

Tree and Vine Crops: Apply 12.8 to 64 fl oz per acre following pruning or wood chip incorporation. ClawEL Debris Delete may be applied with typical herbicides and fertilizers used in spring or fall. Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

### Tank Mixing and Performance Considerations

- Mix with water for a minimum total spray volume of 10 gallons per acre to ensure proper coverage.
- ClawEL Debris Delete may be applied with most fertilizers and pesticides.
- Co-applying ClawEL Debris Delete with liquid fertilizers such as AMS, UAN, ATS, 10-34-0, KTS may help further accelerate decomposition.
- Incorporation of the residue into the soil through tillage after application of ClawEL Debris Delete may further accelerate the decomposition rates of residue.
- Mechanically sizing residue through chopping, mowing, or shredding will hasten residue breakdown.
