ClawEL HS COC is a high-quality paraffinic oil with high surfactant concentration designed for use in crop protection spray programs. This product may effectively be used at lower rates than traditional crop oil concentrates and enhance the activity and performance of pesticides. Therefore, care must be taken in treating crops during periods when plants are subjected to drought stress, high temperatures and high humidity.

Directions for Use

Read and follow the precautions, restrictions and recommendations on the labels of pesticides used with this product. Use according to the most restrictive label directions for each product in any tank mix.

GENERAL USE

- •3-4 pints per 100 gallons (0.375-0.5% v/v) of spray solution when herbicide is bels is commend or require the use of a crop oil concentrate.
- •1 pint/acre for spray volumes below 12.5 gallons per acre.

CROP OIL CONCENTRATE (COC) REPLACEMENT RATES

•This product maybe applied 1/2 to 2/3 rate of traditional crop oil concentrate adjuvants.

AERIAL APPLICATIONS

•8 fluid ounces per acre by air with fungicides and insecticides.

COMPATIBILITY: This product is compatible with plost pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank half full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules. (2) Wettable powders. (3) Flowables. (4) Solutions. (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of this product. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.
